Acknowledgment of Risk

I hereby acknowledge and agree that participation in activities at Michigan Area United Methodist Camping comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Michigan Area United Methodist Camping participation and that said list in no way limits the operation of this Agreement.
