

**Participant Waiver, Release, Indemnification of All Claims &  
Covenant Not to Sue** (rev 2023)

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in entirety. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your participation in programs associated with Michigan Area United Methodist Camping, now or at any time in the future.**

**Acknowledgment of Risk**

I hereby acknowledge and agree that participation in activities at Michigan Area United Methodist Camping comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with my child, or child in my custody, participation in these activities including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Michigan Area United Methodist Camping participation and that said list in no way limits the operation of this Agreement.

**Coronavirus / COVID-19 Warning & Disclaimer**

Coronavirus, COVID-19 is an **extremely contagious** virus that spreads easily through person-to-person contact. **COVID-19 can lead to severe illness, personal injury, permanent disability, and death. I acknowledge that participating in Michigan Area United Methodist Camping programs or facilities could increase the risk of contracting COVID-19.** Michigan Area United Methodist Camping in no way warrants that COVID-19 infection will not occur through participation in Michigan Area United Methodist programs of accessing Michigan Area United Methodist facilities.

**Waiver, Release, Indemnification & Covenant Not to Sue**

In consideration of my child's participation at Michigan Area United Methodist Camping, I agree to HEREBY release on behalf of myself, my heirs, representatives, executors, administrators, and assigns the MICHIGAN AREA UNITED METHODIST CAMPING, its officers, directors, employees, volunteers, agents, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Michigan Area United Methodist Camping on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of Michigan Area United Methodist Camping facilities/equipment or participation in programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of my minor child's participation in Michigan Area United Methodist Camping, I, the undersigned, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my child's participation.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in participation and that I am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, my child sustains while participating and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death. I further certify that my child is in good health and that he/she has no conditions or impairments which would preclude my child's safe participation.

I am of lawful age and otherwise legally competent to sign this agreement. I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement, after having carefully read it, of my own free will.
